Face-to-face Classes Resume

St. Mary's University resumed the face-to-face classes on November 9, 2020 (Tikimt 30, 2013E.C.) after eight months of closure due to COVID-19. As per the direction given by the Ministry of Science and Higher Education (MoSHE), graduating students of undergraduate programs have resumed classes.



The Executive Vice President, the Vice President of Research and International Relations Office, the Director of International Relations and Communication Office, and the Director for Academic Affairs visited the classrooms.

A graduating student from Faculty of Informatics told International Relations and Communication Office that he was excited to have classes resumed.



Regarding the support he received during the “stay home” period, he said, students had been provided with notes to read. “I was very happy to have re-

ceived the notes because they helped me continue studying courses while the face-to-face sessions were on hold,” he noted. He also added that when students stayed at home, instructors sent them exams to check if students were reading the materials sent to them and gauge their level of understanding. These, according to him, have helped him and his classmates to refresh their memories.

He also commented that covering the remaining portions of courses within the given short time may be difficult and thus much is expected from students to work hard. He said he has prepared himself toward that end.



Stating that it was not easy to resume classes after such a long time of departure from face-to-face classes, another student expressed her excitement to be back to University. “I’m very happy to see classes resumed,” she reiterated.

She added she and her classmates attended courses virtually and received virtual support, which were useful to prepare them for face-to-face learning. Conforming that she is committed to do her best to successfully complete her study, she underscored that students will have to put an utmost effort to learn independently and the University should help them get more lessons on skill-oriented course.

COVID-19 Governance and Input Affairs Committee Briefs Compliance Officers

COVID-19 Governance and Input Affairs Committee of St. Mary's University briefed SMU Compliance Officers on November 04, 2020. The Dean of Student Support Services Office welcomed the self-motivated Compliance Officers, all of whom were students of SMU, and introduced the agenda and Ato Desalegn Berie, Chair of COVID-19 Governance and Input Affairs Committee and Vice President for Business and Administration, who made the briefing.



Appreciating students for accepting the University's call and volunteering to serve as Compliance Officers during the face-to-face classes which would resume the following week, Ato Desalegn Berie explained St. Mary's University's preparations toward resuming classes while ensuring adherence to COVID-19 prevention protocols.



According to him, different structures have been created to make effective and efficient response to the emerging needs and challenges caused by COVID-19. A University-wide taskforce, which is answerable to the University Senate, is tasked to lead

the teaching learning activities while ensuring the health and safety of the University community. He said, "Working under this taskforce, there are three committees which have different foci." Highlighting the core roles of the three committees, he elaborated on the specific duties and responsibilities of the Governance, Follow up and Input Affairs Committee, which he heads.

He made it clear that an institutional guideline which clearly outlines the responsibilities of the task force and the committees working under it has been developed in light with the national guideline prepared to ward-off the spread of COVID-19.



The major responsibility of Compliance Officers, according to Ato Desalegn, is to ensure that students conform to the COVID-19 prevention protocols in order to enable healthy environment during their stay on campus. He also described the procedures the Compliance Officers should follow while discharging their responsibilities.

Finally, a coordinator was assigned on voluntary basis to help the Compliance Officers work as a strong team in a coordinated manner and enable timely exchange of information with pertinent offices of the University.

Orientation Sessions Held

St. Mary's University held orientation sessions for the graduating students of undergraduate programs on November 3, 2020, as part of preparation to resume classes, which have been closed for seven months due to COVID-19.



Opening remarks were made by Misganaw Solomon (PhD), Vice President for Research and International Relations, who warmly welcomed students back to their university. He briefed the students about the overall preparations made by the University to enable them to pursue their education in safe and secured environment.



W/ro Mekdes Adane, Dean, Student Support Services Office highlighted the precautionary measures students should take during their stay on campus to prevent themselves from the Virus. She also explained the preparations made by the University to make students learn in safe environment.

Highlighting the roles of SMU COVID-19 Compliance Officers, W/ro Mekdes said a team of volunteer students who will work with the University to ward-off COVID-19 has been put in place. W/ro Mekdes urged all students to collaborate with these Officers. Besides, she indicated that students can contact the Guidance and Counseling Unit and First Aid Clinic for any assistance and can use the telegram channels

of their respective departments for online support. She also provided important telephone numbers the students can use in case of COVID-19 emergencies.



Students were also informed about academic matters such as class resumption date, course delivery mechanisms, University's Learning Management System (LMS), responsibilities of students and instructors in the "New Normal", and additional academic support students would get.

Orientation was also given on online exam. This was presented by Henok Teklu, Director, ICT Development and Support Unit, SMU. He demonstrated how the system works.

Participants raised questions and concerns and detail responses were given by the orientation facilitator.

Senate's extraordinary session on resumption of classes



St. Mary's University Senate held an extraordinary meeting on October 22, 2020 to hear reports on the preparations under taken by the various academic and administrative operational units toward resump-

tion of classes amidst the COVID-19 pandemic. Aware of developments related to opening higher education institutions, which have been closed nationwide since March 17, 2020 to ward-off the spread of the pandemic, the meeting was prompted by the deliberations made in Hawassa the previous week at a meeting comprising policy makers from the lower House of Representatives, Ministers and university presidents.



The Hawassa high-level meeting had the key agenda of the preparations under taken by universities to resume classes putting in place all the protocols laid down by the Ethiopian Ministry of Health together with the Ministry of Science and Higher Education to stave off the spread of COVID-19. At that meeting, Misganaw Solomon (PhD), V/P for Research and International Relations, presented St. Mary's experiences focusing on the activities done throughout the time of closure of in-person classes and the preparations the University has under taken to resume classes. He sensitized Senate members with the key issues that transpired at the Hawassa deliberations, which include roles of on-and off-campus stake holders before and after resumption of classes.

In line with institutionalizing the protocols that ensure the health safety of students and staff, the following were considered to be requirements that universities are expected to meet: Governance structure; facilities & infrastructure; Campus peace plan; Academic calendar in tune with COVID-19 protocols; and Monitoring & Evaluation scheme.

It was also noted that the need for giving psychosocial support to incoming students and prioritizing

the availability of online materials to minimize person-to-person contacts were given due importance. Meanwhile, in our case, the Property, Facility and General Services Management Unit, under the leadership of Ato Desalegn Berie, the V/P for Business and Admin, played a significant role in the combat against the spread of the virus. Newly-installed hands-free plumbing fixtures, additional water tanks, and the rearrangement of seats, in conformity with COVID-19 protocols, are among the core activities carried out by the Unit. While the posters and flyers were put in place by the SSSO, the overall follow up was the V/P's responsibilities, as Chair of the Task force involving the Director for Academic Affairs, the Dean of Student Support and Services Office, the Dean for the Faculty of Accounting & Finance, and the Head of the Property, Facility and General Services Management Unit.



Chaired by the President, SMU, the Senate was also briefed by the EVP, and the Special Assistant to the President, pertaining to the Academic preparation of the Under graduate Program and that of the Graduate Program, respectively.

Finally, appreciating the work of the entire operational units, the President made his closing remarks highlighting on the importance of understanding the context, enshrining the culture of sense of immediacy in responding to current situation, cherishing team work, nurturing out of the box thinking and sorting out response methods to events since the same approach may not be compatible to all situations.

Research and Development

Mizan Law accredited

Mizan Law Review, one of the Bi-annual Journals of St. Mary's University, has been accredited by the Ministry of Science and Higher Education. In a letter issued on Tahsas 09, 2013 E.C. (December 18, 2020), the Ministry of Science and Higher Education has indicated that Mizan Law Review was recognized among other qualified journals being published by Ethiopian higher education institutions.

Mizan Law Review is published twice a year by the Center for Law in Sustainable Development (CLiSD) of St. Mary's University. The journal came into being in 2007 by the then Faculty of Law of St. Mary's University, which offered undergraduate Law programs until the Ethiopian Government banned Private Higher Education Institutions from admitting Law and teacher education programs in 2010. Following the ban, St. Mary's University set up a unit called "Center for Law in Sustainable Development (CLiSD)" to continue the University's contribution to legal research and other engagements such as hosting the National Ethiopian Rounds of the Philip C. Jessup Moot Court Competition.


Mizan Law Review has published twenty eight issues in fourteen volumes during the last 14 years without interruption, maintaining its quality and standards. The Editorial Team, the Distribution Team, Advisory and Editorial Boards, article contributors and reviewers have been instrumental in sustaining the publication of the journal.

Mizan has won reputability because of the scholarly quality of its contents. The diverse topics addressed through the journal have made significant contributions to the teaching of Law and its practices in Ethiopia. The journal is disseminated to higher education institutions and various public service providing institutions.

It is indexed in DOAJ since 8 September 2010. In addition to the print version, it is also available on AJOL, Hein Online and Ebsco Host for local and international readers.

Mizan Law Review is one of the 16 journals accredited by the Ministry for the first time.

14th National Student Research Forum Held



St. Mary's University held the 14th National Student Research Forum on January 5, 2021 via zoom. The aim of the Forum was to promote the culture of knowledge and skill transfer among students, academicians, and researchers in different disciplines.

Opening remarks were made by Tedla Haile, Executive Vice President, St. Mary's University. Recognizing the efforts of different offices and students, the Executive Vice President wished the Forum fruitful deliberations.

Eight graduating students of St. Mary's University presented their research papers which dealt with human resource management, marketing, tourism, accounting and finance and ICT. Participants raised questions to which paper presenters responded.





A closing speech was made by Senait Getahun, Coordinator of the Forum from the Research and Knowledge Management Office of St. Mary's University. She expressed her gratitude to paper presenters for their excellent presentations and applauded faculty deans and department heads for the support they provided to students who made the Forum happen at such a remarkable level.

The Forum was attended by St. Mary's University staff, research paper presenters, students, and local media representatives. Among the attendees were the President of St. Mary's University and the Vice President for Research and International Relations who commended the efforts made to put the Forum together at this difficult time and encouraged students to keep up the good job they have started.

Partnership, Outreach and Community Services

SMU Participated in Training on Support System for COVID-19 Response

St. Mary's University participated in a workshop held on Mental Health and Psychological Support System for COVID-19 Response at Adama Selam Hotel, from October 29 to 30, 2020. An opening speech was made by Dr. Ebba Mijena from the Ministry of Science and Higher Education. He highlighted the challenges higher learning institutions had faced while trying to offer education online during the period universities were closed due to the outbreak of COVID-19. Informing participants about the top-level decision made to reopen Universities, he underscored the need to adjust to the "New normal". He listed out the precautionary measures to be strictly adhered to. These include establishing Mental Health Psychosocial Support (MHPSS) Unit, setting up a strong task force to facilitate the provision of MHPSS, organizing orientation on MHPSS, and strengthening counseling services.

Following the opening speech, Ato Noah from the Ministry of Health made a short briefing on what has to be done. He stressed the need for focusing on preventive mechanisms such as wearing masks, social distancing, and washing hands frequently. He also emphasized the need for case management which is critical as COVID-19 cases are increasing. "If someone is found positive, he/she should be confined in quarantine and needs be counseled and supported; he/she should not be negatively isolated," he strongly advised.

Dr Mulat Asnake from Addis Ababa University made a presentation on "Mental Health and Psycho-

social Support for University Students in the context of COVID-19". His presentation focused on, among others, mental health and psychological readiness, psychosocial problems of university students, factors that may lead to psychosocial problems, psychosocial intervention for university students, and enhancing emotional intelligence of university students.

Finally each University developed an action plan to implement MHPSS in response to COVID-19. St. Mary's University was represented by staff from Student Support Service Offices and Director, Career and Internship Unit.

St. Mary's Attended Anniversary Event

St. Mary's University took part in the 25th anniversary of Fana Broadcasting Corporate held at Intercontinental Addis Hotel, on October 24, 2020. Welcoming and opening speeches were made by Dr. Getachew Dingu, Director, Ethiopian Broadcasting Agency, followed by Ato Nigussu Telahun, Commissioner, Job Creation Commission. There were two groups of panel discussions: one in the morning and the other in the afternoon.

Fana Broadcasting was established in 1987 by transmitting in two languages: Amharic and Afan Oromo in the areas of Addis Ababa. Currently, it has 12 FM Radio Stations broadcasting in Amharic and 9 additional languages including Arabic. It has around



1,000 employees. The 12 Fana FM Radio Stations are in Addis Ababa, Dessie, Debre berhan, Shashemene, Haramaya, Assela, Wolaiyta Soddo, Jimma, Nekemte, Gondar, Mekelle, and Mizan Aman.

SMU Attended MoSHE's Meeting

St. Mary's University took part in the meeting organized by the Ministry of Science and Higher Education (MoSHE) from October 16-18, 2020, where the Ministry announced that higher education institutions will resume face-to-face classes as of Tikimt 23, 2013E.C. (November 02, 2020). His Excellency Dr Samuel Urkato, Minister, Ministry of Science and Higher Education, urged higher education institutions to finalize their preparation for resumption of classes and report the results to the Ministry before November 02, 2020.

In a meeting held with stakeholders at South Star Hotel, Hawassa, on October 16, 2020, the President of Hawassa University, co-organizer of the meeting, made a welcoming speech and the Honorable Ato-Tagesse Chafo, Speaker of the Ethiopian House of People's Representatives, made an opening speech in which he called for strong collaboration among stakeholders and well-thought out plans to resume the face-to-face classes in good health, peace and security.

Dr Mulu Nega, State Minister, MoSHE, and Dr Andualem Admassie, Director General, HERQA, presented preparedness assessment results of 45 public universities and 113 private higher education institutions, respectively. It was made clear that most of the higher education institutions have finalized their preparations which would enable them resume classes. To showcase the institutions' preparation status, two sample institutions - Hawassa University from public and St.Mary's University from private - shared their preparation plans.

The reports presented by MoSHE and HERQA indicated that some higher education institutions from both the public and private sectors alike have yet some tasks to complete their preparation. According to Dr Andualem Admassie, some private higher education institutions seem to be uncertain about class

resumption and prefer to wait for the exact reopening date of classes to invest more money on the preparation. This uncertainty has resulted in partial accomplishment of class resumption preparation. He also highlighted the challenges the private sector has been facing since the closure of classes and expressed his concern on some institutions' sustainability.

The meeting had two major agenda items– resumption of face-to-face classes and ensuring peaceful teaching and learning at all higher education institutions.

In attendance were the Speaker of Ethiopia's House of People's Representatives, members of the House of People's Representatives, Ministers, State Ministers, public university board chairs, Presidents and Vice Presidents of all public universities and some private higher education institutions, heads of TVET offices and institutions, and Presidents of Student Unions. SMU was represented by the Vice President for Research and International Relations.

SMU Took Part in GERD's Meeting

St. Mary's University took part in a meeting organized by the Office of National Council for the Coordination of Public Participation in the Construction of Grand Renaissance Dam on October 2, 2020 at Friendship International Hotel in Addis Ababa. The objective of the meeting was to discuss the 2012 E.C. performance and 2013 E.C. annual plan of the Office. Before the official opening of the meeting, different videos on the construction of the GERD were displayed to participants.

Opening speech was made by Ato Hailu Abreha, Director, Media and Communication Directorate. Following the opening speech, the 2012 E.C. annual plan performance and the 2013 E.C. annual plan of the Office were presented by W/ro Fikirte Tamir and Ato Tagel Kenubih, Deputy Directors of the Office, respectively. The presentation on the 2012 E.C. annual plan performance had four main parts: public participation, fund raising, linkage with environmental protection and public diplomacy. Strengths and challenges encountered were also presented. In her presentation, W/ro Fikirte indicated that the

2012 E.C. performance was highly appreciative compared to performance of the previous year despite the COVID-19 challenges. The presentations were followed by a discussion session on both presentations.

Finally, the Ministry of Water, Irrigation and Energy made a presentation on current performance status of the GERD and discussion was made on the presentation. SMU was represented by a staff from RaKMO.

St. Mary's University Participated in Workshop on World Tourism Day

St. Mary's University participated in a half-day workshop convened by the Ethiopian Tourism Professionals Association (ETPA) on September 20, 2020 at Elilly Hotel, Addis Ababa. The workshop deliberated on the theme, "Tourism and Rural Development".

Two staff members from the Department of Tourism and Hospitality Management of St. Mary's University, Shiferaw Tadesse, Department Head, and Mekonnen Gebre-Egziabher, instructor in the Department, attended the workshop, where they actively participated by forwarding constructive ideas.

Dr. Theodoros Atilabachew made a presentation on Sustainable Rural Tourism Development followed by participants' discussions on Ethiopia's potential of rural tourism and the different development approaches in light of best experiences in foreign countries.



The participants also deliberated on ways to bolster and reinforce the Association, as well as its future role in contributing to and promoting the tourism sector in the country.

አስተዳደራዊ መመሪያዎች ተሻሽለው ፀደቁ

የዩኒቨርሲቲው አስተዳደር ካውንስል ልዩልዩ አስተዳደር-ነክ መመሪያዎችን አዘጋጅቶ በማጽደቅ ሥራ ላይ አውሎ ሲገለገልባቸው መቆየቱ ይታወሳል። እነዚህ መመሪያዎች ከወቅታዊ ሁኔታና በየጊዜው ከሚወጡ ዐዋጆች አንጻር እየተገመገሙ ማሻሻያ እንዲደረግባቸው በማስፈለጉ አስተዳደር ካውንስሉ ባለፉት ወራት በአምስት ነባር አስተዳደራዊ መመሪያዎች ላይ አስፈላጊውን ማሻሻያ በማድረግ ሥራ ላይ እንዲውሉ አድርጓል። ማሻሻያ የተደረገባቸው መመሪያዎች ሥራ ላይ ከመዋላቸው በፊትም ስለነዚህ ማሻሻያዎች አግባብነት ላላቸው የዩኒቨርሲቲው አመራር አካላት በቂ የግንዛቤ ማስጨበጫ ሥራ መሠራቱም ታውቋል።

ኮቪድ-19 መከላከልን ማዕከል ያደረገ ትምህርት የማስጀመር ቅድመ-ዝግጅት ሥራ ተካሄደ

በኮቪድ-19 መከላከል ምክንያት ከመጋቢት 2012 ዓ.ም. ጀምሮ የተቋረጠውን ትምህርት ለማስጀመር መንግሥትና የጤና ሚኒስቴር ባስቀመጡት አቅጣጫና የሳይንስና ክፍተኛ ትምህርት ሚኒስቴር ባወጣው መመሪያ መሠረት ቅድስት ማርያም ዩኒቨርሲቲ ይህንን ሥራ ለመምራት የሚያስችል የራሱን ማኑዋልና በማኑዋሉ መሠረት ተገቢውን የቅድመ ዝግጅትና ትምህርት የማስጀመር ሥራዎችን የሚያከናውን የኮቪድ-19 መከላከል ግብረ-ኃይል መዋቅርና ኃላፊነት በማዘጋጀት ወደ ሥራ ገብቷል።

በዚህም መሠረት በዩኒቨርሲቲው ፕሬዚዳንት የሚመራ ስድስት አባላት ያሉት ግብረ-ኃይልና በምክትል ፕሬዚዳንቶች የሚመሩ ሦስት ኮሚቴዎች ተቋቁመው አስፈላጊውን የቅድመ-ዝግጅት ሥራ ሲያከናውኑ የቆዩ ሲሆን በመጀመሪያ ተመራቂ ተማሪዎችን፣ ቀጥሎም ተመራቂ ያልሆኑ የቅድመና ድኅረ ምረቃ ተማሪዎችን የ 2012 ዓ.ም. የትምህርት ዘመን ትምህርት የማስጨረስ ሥራ በአግባቡ እንዲከናወን የሚያስችል ሥራ መሥራታቸው ታውቋል። የቅድመ-ዝግጅቱም ሆነ ትምህርት የማስጀመርና የማስጨረስ ሥራው ተገቢውን ሁለንተናዊ ዝግጅትና ኮቪድ-19ን የመከላከል ሥራ ማዕከል አድርጎ የተከናወነ ሲሆን በዚህ ረገድ የሚካሄደው የግብረ ኃይሉና የኮሚቴዎቹ ሥራ በየጊዜው እየተገመገመ ተጠናክሮ መቀጠሉም ታውቋል።

በሀገራችን ሉዓላዊነትና በሰሜን ዕዝ የመከላከያ ሠራዊታችን ላይ የተሰነዘረውን ጥቃት ለመከላከልና ህግ የማስከበር ሥራን ለማከናወን ለሚደረገው ሀገራዊ እንቅስቃሴ ተቋማዊ የገንዘብ ድጋፍ ተደረገ ። ዩኒቨርሲቲው ከልደታ ክፍለ ከተማ፣ ወረዳ 10 አመራር አካላት ጋር ተወያይቶ በደረሰበት ስምምነት መሠረት ለዚህ አገራዊ ሥራ የሚውል የብር 50,000 (ሃምሳ ሺህ ብር) ድጋፍ የሰጠ ሲሆን ለወደፊትም ከመከላከያ ሠራዊታችን ጎን በመቆም ታፍራና ተከብራ የኖረችውን ኢትዮጵያን ሉዓላዊነት ለማስከበር በሚደረገው ጥረት ድጋፉን አጠናክሮ እንደሚቀጥል ያለውን ዕኑ አቋም ገልጿል።
